The Special Resolution proposes to amend Rule 20 of the Constitution to read "The number of Full Members having the right to vote in the election of the Board shall at all times be no less than 15% of the total number of Full Members of the Club".
- 8. In accordance with Rule 26 of the Constitution to consider and if thought fit to approve Life Membership for 2 Golfing Members of the Club. A Life Member shall be any Member who has rendered outstanding service to the Club or its Members. The Board has approved these nominations as per Rule 26(d). Life Membership shall be granted only by votes of not less than two-thirds of the Members being present and entitled to vote on the Notice of Motion at the meeting. Voting shall be by secret ballot.
